4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Partially used containers should be resealed between uses for maximum storage stability.

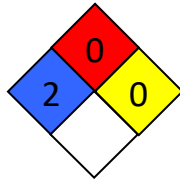
